

## Polanyi's Liberalism in the Forties

### Three Zoom Sessions on May 15, 22 and 29, 2021

Michael Polanyi was a prolific writer from 1940-1950. A quick look at one of the standard bibliographies suggests Polanyi published 20 scientific articles and more than 50 non-scientific books, articles, reviews and letters in this decade. The material in the archival Michael Polanyi Papers (MPP) makes clear that Polanyi's published non-scientific writing was only a part of a much larger collection of incomplete and abandoned writing projects. Polanyi's effort to reconceive and reform liberalism in the midst of the tumultuous events of the forties seems to be the thread that binds much of this diverse writing together. The three Zoom presentations/discussions will each week focus on particular Polanyi texts, some published and some unpublished, that reflect the several dimensions of Polanyi's thinking about liberalism. This includes (but is not limited to) the problems of the inherited liberal tradition and its epistemic weaknesses, the challenge of totalitarianism and its roots in modern scientism, and how to re-imagine liberalism by re-conceiving liberty and the changing social order.

Although it is preferred that participants plan to commit to participate in all three of these 1.5 hour Zoom sessions (since they fit together as a set, like the earlier Duke Lecture Zoom sessions), it is permissible to join only sessions that fit your schedule. As was the case with past Polanyi Society-sponsored Zoom sessions, if you register, you will be sent a link for all sessions. All sessions will be recorded and posted on the Zoom cloud within approximately 24 hours so it is possible to review recordings of sessions.
